## UWCM ANNUAL GENERAL MEETING – PRESIDENT'S REPORT

I am pleased to report that the UWCM remains engaged and continues in its mission: *Social interaction, social responsibility, and growth of women in all areas of life.*

### Program

This season our Program Chair, Margaret Jackson, enlisted diverse speakers, with emphasis on female leaders in their respective fields. They included: President of Premiere Moisson Lillian Colpron; artist and photographer Bonnie Folkins; wine expert Bill Zacharkiw; founding director of Persephone Productions Gabrielle Soskin; motivational retirement speaker Catherine Gilbert; writer and publisher Linda

Leith; and president of Centraide Lili-Anna Peresa. A donation was made to each speaker's favourite charity. This allowed our club to support such organizations as Sun Youth, Centraide, Gaia Nova, Persephone Productions, The Atwater Library, The SPCA Montérégie, and Our Harbour.

### Interest Groups.

UWCM had 11 active interest groups, our most popular being Wine Tasting, Supper Club, and Art Etc. The list also includes: Chit Chat *en Français*, Carte Blanche, Movie Club, Outdoor Ladies, Reclaim Your Body, Scrapbooking, Stage & Soirée, and Travels With My Aunt. During Volunteer Week in

### Advocacy

Three advocacy initiatives were part of our club activities. A group of our members attended the Polytechnique Memorial on December 6th. Letters were sent to Quebec Premier Pauline Marois, as well as various MNAs, denouncing the PQ Charter of Values. Lastly, in support of the 2013 CFUW resolution on lowering sodium intake, Jill Wood wrote a piece for our newsletter in which she recommended ways to reduce salt in our diets.

### Website

## ANNUAL REPORT 2013 – 2014

Fundraising began with the launch of our second Annual Giving Campaign in late October. We were pleased to have received \$3,370 from our members. However, we were somewhat disappointed that the amount received was half of that of last year from fewer members. We were most grateful for the donation of \$3,000 from the Board of Directors of UWCM, which brought our total donations last fall to \$6,370. We shall be completing our fundraising activities on May 28th with our evening of wine and food tastings *Savour the Flavour: Celebrating Quebec Terroir* on the rooftop terrace at Concordia University.

The monies generated from both the Annual Giving Campaign and the *Savour the Flavour* evening will be disbursed to women students attending Concordia University as well as to young women students enrolled in the Professional Theatre Program at Dawson College. In addition to supporting academic pursuits, the Foundation also supports local women's shelters.

The Foundation Trustees are most grateful to the Fundraising Committee who organized and brought about both of these fundraising activities.

## Report from Ad Hoc Committee on Premises

---

A few facts to begin:

- Our charter calls for the UWCM to “provide a clubhouse and other conveniences for the members...” The letters patent say that the UWCM must “...acquire, lease or maintain... premises or other conveniences for its members, to the extent to which it may seem useful or advisable, in order to provide a meeting place for its members...”
- The Coach House is in a state of disrepair. Water has infiltrated the ground floor space that we rent and caused damage and produced mould.
- We pay the Atwater Club \$1,839.60 per month to rent the Coach House. It is used for various meetings (UWCM Board, Governance and Foundation Committee) and for special events. During the whole of 2013, the Coach House was used 55 times. To date in 2014, it has been used 29 times.
- The Club runs at a deficit every year. In 2013, expenses exceeded income by nearly \$30,000. When the Club was formed in 1927, the membership was about 250; today we have just over 100 members.
- These facts triggered the Board to strike a small Ad Hoc Committee (Margaret Jackson, Jill Wood, Maya Bergeron-Métivier) to explore alternatives to renting the Coach House.
- We are exploring renting space at the Atwater Library & Computer Centre where we could hold our various meetings. (We would need to hold our dinner meetings/special events elsewhere.) The space is unfurnished and we would need to pay for any leasehold improvements (i.e. installing a coffee station, shelving and storage, etc.).
- We are in discussions with the Atwater Club regarding their continuing to host our dinner meetings, including taking reservations and billing our members the cost of their suppers if we are no longer renting the Coach House. We may have to pay for renting the dining room.
- We are waiting to hear from the owner of the Atwater Club/Coach House regarding what and when renovations are planned and how our rental agreement will be affected.

When we have marshalled all the information and have firm costs, we will call a Special General Meeting to present the results of our study and, if appropriate, call for a vote should a move be recommended by the Ad Hoc Committee.
